TERMS & CONDITIONS

- Definition** : The term 'Exhibition' shall mean "FAPSIA MSME MEGA EXPO". The 'Exhibitor' shall mean the party to whom space has been allotted and the term 'organizer' shall mean FAPSIA.
- Agreement** : A binding contract shall come into existence between the Exhibitor and the Organizer on acceptance of the Application form in writing by the Organizer. No Changes to these Terms shall be valid unless signed in writing by the duly authorized representatives of both parties.
- Stall Allocation** : First Come First Allotment. Priority will be given to exhibitors in the order of application receipt, the size of the space requested, and the nature of the exhibits. The organizer has the authority to make any adjustments to stall space assigned if deemed necessary. The Exhibitor may not sublet or exchange in whole, or in part, assigned space without prior permission from the organizer.
- Cancellation Terms** : In case of participation cancellation, refund would be as under:
- Till 5th Feb 2020 - 50% Refund
 - Post 5th Feb 2020 No Refund will be given
- Rights of Organizers** : The organizers reserve the following rights
- To reject any application for space without assigning any reason thereof.
 - To amend these conditions for participation and additional rules and regulations for participants from time to time, this shall be binding on all participants.
 - To change the stall location or to make certain changes, alterations, curtailments in the final allotments of stall areas with respect to that originally booked by the exhibitor.
 - To refuse permission to an exhibitor to clear their stall if they have not cleared all dues to the organizers, and to hold their exhibits or other goods as collateral security till the dues are cleared and charge demurrage and administrative charges.
- Permission / Approvals** : All verbal agreement, permission, individual approvals or special authorization shall be deemed to be valid only if confirmed in writing by the organizers.
- Exhibition Layout** : The organizer reserves the right to make amendments in the exhibition layout, including re-locating the stalls; without notifying the exhibitors. The stall numbers cannot be changed even if the participant decides to shift location of the stall on the exhibition floor.
- Failure of services** : The organizers will use their best endeavors to ensure the supply of the services of the Expo, and of the authorized contractors, but there shall not be any liability to Exhibitor for any loss or damage of such services shall wholly or partially cease to be available.
- Final Decision** : In case of any dispute in interpretation of conditions for participation, or between exhibitors, the final decision is of the Organizers namely "FAPSIA" shall be binding on all parties.
- Jurisdiction** : The implementation of these regulations or supplementary stipulations laid down by the organizers relating to the exhibition shall be deemed to be domiciled at the office of the Vijayawada Courts. All disputes arising shall be judged according to Indian Laws and subject to Vijayawada jurisdiction only.
